
7. "Through the wall" air conditioners. No "through the wall" air conditioners may be installed on the front wall or sidewall of any building in The Subdivision.




8. Compressors for central air. No outside compressors for central air conditioning units may be located other than in the rear yard and must be ins...he side of homes at that time will be grandfathered


